HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2599

(Reference to printed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Title 28, chapter 7, article 5, Arizona Revised Statutes,
3 is amended by adding section 28-2157.01, to read:

4 28-2157.01. Vehicle registration; voluntary contribution;
5 delayed repeal

6 A. THE APPLICATION FOR INITIAL REGISTRATION AND FOR RENEWAL OF
7 REGISTRATION OF A MOTOR VEHICLE SHALL ALLOW THE APPLICANT TO AFFIRMATIVELY
8 ACT TO VOLUNTARILY DONATE TEN DOLLARS TO BE USED TO OPERATE, MAINTAIN AND
9 MAKE CAPITAL IMPROVEMENTS TO STATE PARKS. IF AN APPLICANT VOLUNTARILY DONATES
10 MONIES PURSUANT TO THIS SECTION, THE DEPARTMENT SHALL ISSUE A STICKER FOR THE
11 PERSON'S MOTOR VEHICLE THAT INDICATES THAT THE DONATION WAS MADE. THE
12 DEPARTMENT SHALL DEPOSIT, PURSUANT TO SECTIONS 35-146 AND 35-147, ALL OF THE
13 MONIES COLLECTED PURSUANT TO THIS SECTION IN THE SUSTAINABLE STATE PARKS FUND
14 ESTABLISHED BY SECTION 41-511.17.

15 B. THIS SECTION IS REPEALED FROM AND AFTER JUNE 30, 2013.

16 Sec. 2. Title 41, chapter 3, article 1.1, Arizona Revised Statutes, is
17 amended by adding section 41-511.17, to read:

18 41-511.17. Sustainable state parks fund; delayed repeal

19 A. THE SUSTAINABLE STATE PARKS FUND IS ESTABLISHED CONSISTING OF
20 MONIES DONATED PURSUANT TO SECTION 28-2157.01. THE ARIZONA STATE PARKS BOARD
21 SHALL ADMINISTER THE FUND. MONIES IN THE FUND ARE CONTINUOUSLY APPROPRIATED
22 AND ARE EXEMPT FROM THE PROVISIONS OF SECTION 35-190 RELATING TO LAPSING OF
23 APPROPRIATIONS. THE ARIZONA STATE PARKS BOARD SHALL USE THESE MONIES TO
24 OPERATE, MAINTAIN AND MAKE CAPITAL IMPROVEMENTS TO STATE PARKS.

1 B. NOTWITHSTANDING ANY OTHER LAW, THE ARIZONA STATE PARKS BOARD SHALL
2 NOT CHARGE A FEE FOR THE DAY USE OF STATE PARKS TO A MOTOR VEHICLE DISPLAYING
3 A STICKER ISSUED PURSUANT TO SECTION 28-2157.01. THIS SUBSECTION DOES NOT
4 PREVENT THE ARIZONA STATE PARKS BOARD FROM CHARGING A FEE FOR SPECIAL
5 SERVICES, INCLUDING TOURS AND OVERNIGHT CAMPING.

6 C. THIS SECTION IS REPEALED FROM AND AFTER JUNE 30, 2013.

7 Sec. 3. Audit, sustainable state parks fund

8 On or before February 1, 2013, the auditor general shall conduct an
9 audit of the sustainable state parks fund established by section 41-511.17,
10 Arizona Revised Statutes, as added by this act, and shall issue a report of
11 its findings to the appropriations committees in the senate and the house of
12 representatives, or their successor committees.

13 Sec. 4. Emergency

14 This act is an emergency measure that is necessary to preserve the
15 public peace, health or safety and is operative immediately as provided by
16 law."
